STUDENT SATISFACTION SURVEY

A Student Satisfaction Survey was conducted at Symbiosis International (Deemed University) during the Academic Year 2022 – 2023. A comprehensive questionnaire, designed to assess the effectiveness of the teaching-learning-evaluation process implemented throughout the specified period. The open survey was distributed to 16, 219 students across 40 constituents, of which 1460 students responded.

The subsequent analysis of the survey data was organized into three distinct sections for a comprehensive examination:

- (i) Teaching-Learning,
- (ii) Assessment, and
- (iii)Other Aspects of Academic Administration/Institution.

This segmentation allowed for a focused evaluation of student perspectives on the various facets of academic engagement and administration.

Analysis:

The examination of various parameters for which responses were solicited reveals, that over 50% of students expressed greater agreement than disagreement. This suggests a positive reception of the teaching-learning process at SIU. Students exhibit a clear understanding of the rationale behind their studies, with most courses effectively covering their prescribed syllabi. Individualized guidance is provided, fostering an academically conducive environment.

Recommendations:

Among the evaluated parameters, those with the least favourable student agreement include:

- · Use of diverse teaching methods/ tools
- · Additional activities
- · Implementation of student feedback

In light of these findings, educators may be encouraged to enhance their efforts in these specific

areas for continuous improvement.
