- Code of Ethics of the University: Organization but the supportive mechanism to establish better connection, coordination, and cooperation between the organization and all its stakeholders. Moreover, the articulated Code of Ethics helps in the process of decision-making during the situation of dilemmas or/and if the situation is debatable
- Policy on E-Governance of the University: In the education domain, like all other professional walks of life, e-Governance solution with their tools of information technology plays a very vital role in the various aspects like Admissions, Finance, Library, Examination, Administration, Academics, and so on. Realizing the extensive effect of e-governance with respect to information, transparency, time efficiency, inclusiveness, and responsiveness; 'Symbiosis International University has created a robust IT infrastructure and facilities at the university and its Constituents
- Policy on Infrastructure Management & Maintenance: This policy for Infrastructure Management of Symbiosis International University has been formulated for managing infrastructure through need analysis considering the guidelines of statutory bodies and developments in technology including educational technology; procurement of infrastructure ensuring its quality and cost; upgradation from time to time; proper accounting and safeguarding by allotting inventory numbers on each equipment and maintaining asset register, upkeep of the equipment through regular cleaning, preventive and corrective maintenance including Annual Maintenance Contracts; insurance against damage and theft and writing off of obsolete equipment. Appropriate equipment and its maintenance and upkeep are essential for quality academics and efficient administration. A comprehensive policy for Infrastructure Management has therefore been prepared and implemented.
